Project Overview

A. Project Description

The Chillicothe Correctional Institution (CCI), located at 15802 OH-104 Chillicothe Ohio was originally opened as a State of Ohio prison in 1966. It is a former site of a military camp during the Civil War that later became a federal penitentiary. CCI is currently a medium security prison with the capacity to house approximately 2,950 men.

This Request for Qualifications (RFQ) is being issued to obtain Professional Architectural/Engineering (A/E) services for the demolition of the existing hospital facility as well as design of a new energy efficient dorm at the Chillicothe Correctional Institution Ohio. This new facility is expected to be modeled after the recently constructed dorm at the Ohio Reformatory for Women (ORW) located in Marysville Ohio which opened in 2018. This new facility will be a 288-bed housing building, with an expected size of approximately 43,200 square feet. The secure perimeter fence is expected to be moved to allow for demo and construction to occur outside of the secured perimeter with the fence being reinstalled following construction.

The development of a complete Program of Requirements (POR) will also be included as part of the Professional Design as an Additional Service. This POR development will include review of the new facility at ORW as well study of the existing site to define the anticipated programmatic scope and the exact building location within the CCI secure perimeter. The project scope will be evaluated, prioritized and defined to align with the project budget. Evaluation of the project construction schedule will also be part of the POR stage.

This project will utilize the Construction Manager-at-Risk (CMR) delivery model. It is currently anticipated there will be at least two Guaranteed Maximum Price (GMPs) negotiated according to the General Conditions (CM at Risk Project). One is expected for demolition of the existing building during early design and one for the new building at the completion of the Design Development phase. It is feasible there may be more if determined to be in the best interest of the project.

B. Scope of Services

As required by the Agreement, and as properly authorized, the selected A/E will provide the following categories of Basic Services: Program Verification, Schematic Design, Design Development, Construction Document Preparation, GMP Proposal and Amendment Support, Subcontractor Buyout Support, Construction Administration, and Project Closeout. Additional Services will include programming, and construction testing and inspection services. Upon award of the Agreement, the selected A/E will commence by developing the Program of Requirements. The selected A/E shall also provide any other Additional Services needed to address the Owner's project requirements.

This project will utilize the Construction Manager at Risk project delivery method. The selected A/E, as a portion of its required Scope of Services and prior to submitting its proposal, will discuss and clarify with the Owner and/or the Contracting Authority, the Owner's project requirements and the cost breakdown of the Architect/Engineer Agreement

detailed cost components to address the Owner's project requirements. The selected A/E will also participate in the Encouraging Growth, Diversity & Equity (EDGE) Program as required by statute and the Agreement.

During the construction period, provide not less than 6 hours (excluding travel time) on-site construction administration services each week, including (1) attendance at progress meetings, (2) a written field report of each site visit, (3) on-site representation comprised of the A/E and its consultant staff involved in the primary design of the project, all having relevant and appropriate types of construction administration experience.

I. Evaluation Criteria for Selection

- Demonstrated ability to meet Owner's programmed project vision, scope, budget, and schedule on previous projects.
- Previous experience compatible with the proposed project (e.g., type, size).
- Relevant past work of prospective firm's proposed consultants.
- Past performance of prospective firm and its proposed consultants.
- Qualifications and experience of individuals directly involved with the project.
- Proposer's previous experience (numbers of projects, sizes of projects) when working with its proposed consultants.
- Specification writing credentials and experience.
- Experience and capabilities of creating or using Critical Path Method (CPM) schedules and of using CPM schedules as a project management resource.
- Approach to and success of using partnering and Alternative Dispute Resolution.
- Proximity of prospective firms to the project site.
- Proposer's apparent resources and capacity to meet the needs of this project.
- The selected A/E and all its consultants must have the capability to use the Internet within their normal business location(s) during normal business hours.

Interested A/E firms are required to address how they will implement Building Information Modeling ("BIM") on the project, experience and level of training of staff related to BIM, incorporation of team partners that have previous BIM experience, and an understanding of collaborative BIM processes, including but not limited to the *State of Ohio BIM Protocol* available at the OFCC website at <https://ofcc.ohio.gov>.

Interested A/E firms are required to submit the *Commitment to Participate in the EDGE Business Assistance Program* form in its Statement of Qualifications (Form F110-330) submitted in response to the RFQ, to indicate its intent to contract with and use EDGE-certified Business Enterprise(s), as a part of the A/E's team. The *Intent to Contract and to Perform* and / or waiver request letter and *Demonstration of Good Faith Effort* form(s) with complete documentation must be attached to the A/E's Technical Proposal. Both forms can be accessed via the OFCC website at <https://ofcc.ohio.gov>. The *Intent to Contract and to Perform* form is again required at the Fee Proposal stage.

If the A/E firm intends to receive points for exceeding the EDGE Participation Goal, it must provide BOTH a completed *Commitment to Participate* form AND a completed *Statement of Intent to Contract and to Perform* forms signed by both parties with its *Statement of Qualifications*.

For all *Statements of Qualifications*, please identify the EDGE-certified Business Enterprises, by name, which will participate in the delivery of the proposed professional services solicited in the RFQ.

Interested A/E firms must indicate on their *Statement of Qualifications*, the locations where their services will be performed in the spaces provided or by attachment in accordance with the requirements of Executive Order 2019-12D related to providing services only within the United States and the requirements of Executive Order 2022-02D prohibiting purchases from or investment in any Russian institution or company. Failure to do so may cause their *Statement of Qualifications* to be rejected.

Firms are required to submit the current version of *Statement of Qualifications* (Form F110-330) available via the OFCC website at <https://ofcc.ohio.gov>.

Electronic submittals should be combined into one PDF file named with the project number listed on the RFQ and your firm's name. Use the "print" feature of Adobe Acrobat or similar software for creating a PDF rather than using a scanner. If possible, please reduce the file size of the PDF. In Acrobat, go to Advanced, then PDF Optimizer. Also, please insert the project number and firm name followed by "SOQ" in the email subject line.

Statements of Qualifications must be submitted electronically by email. Submittals are limited to one email with a maximum file size of 25 MB.

Firms are requested to identify professional registrations, memberships and credentials including: LEED GA, LEED AP, LEED AP+, CCCA, CCM, CCS, CDT, CPE, DBIA, and any other appropriate design and construction industry credentials. Identify that information on the resume page for individual in Block 22, Section E of the F110-330 form.
