Project Overview

A. Project Description

Ohio Deaf Blind Educational Services provides residential educational services in Columbus to school-age (grades K-12) deaf, hard of hearing, blind, visually impaired youth and students with multiple disabilities so that they may become self-sufficient members of society. The facilities are located at 5220 N. High Street, Columbus, Ohio 43214 (Blind campus) and 500 Morse Rd, Columbus, Ohio 43214 (Deaf campus).

This project is to construct a vehicle and pedestrian bridge over Bill Moose Run between the Ohio School for the Blind and Ohio School for the Deaf campuses.

Funding for the construction of this project will be split over two biennia with \$3,500,000.00 funded during the current biennium (2025/2026) and \$11,500,000.00 expected to be added for the next biennium (2027/2028). Preconstruction and site work GMP is expected to be funded as part of the initial funding of the current biennium (Phase 1) with the remaining construction being funded in the next biennium (Phase 2).

B. Scope of Services

As required by the Agreement, and as properly authorized, the selected A/E will provide the following categories of Basic Services: Program Verification, Schematic Design, Design Development, Construction Document Preparation, GMP Proposal and Amendment Support, Subcontractor Buyout Support, Construction Administration, and Project Closeout. Additional Services will include programming, and construction testing and inspection services. Upon award of the Agreement, the selected A/E will commence by developing the Program of Requirements. The selected A/E shall also provide any other Additional Services needed to address the Owner's project requirements.

This project will utilize the Construction Manager at Risk delivery method. The selected A/E, as a portion of its required Scope of Services and prior to submitting its proposals, will discuss and clarify with the Owner and/or the Contracting Authority the cost breakdown of the Architect/Engineer Agreement detailed cost components to address the Owner's project requirements. Participate in the Encouraging Diversity, Growth & Equity (EDGE) Program as required by statute and the Agreement.

During the construction period, provide not less than 4 hours (excluding travel time) on-site construction administration services each week, including (1) attendance at progress meetings, (2) a written field report of each site visit, (3) on-site representation comprised of the A/E and its consultant staff involved in the primary design of the project, all having relevant and appropriate types of construction administration experience.

- Previous experience compatible with the proposed project (e.g., type, size).
- Relevant past work of prospective firm's proposed consultants.
- Past performance of prospective firm and its proposed consultants.
- Qualifications and experience of individuals directly involved with the project.
- Proposer's previous experience (numbers of projects, sizes of projects) when working with its proposed consultants.
- Specification writing credentials and experience.

- Experience and capabilities of creating or using Critical Path Method (CPM) schedules and of using CPM schedules as a project management resource.
- Approach to and success of using partnering and Alternative Dispute Resolution.
- Proximity of prospective firms to the project site.
- Proposer's apparent resources and capacity to meet the needs of this project.
- The selected A/E and all its consultants must have the capability to use the Internet within their normal business location(s) during normal business hours.

Interested A/E firms are required to submit the *Commitment to Participate in the EDGE Business Assistance Program* form in its Statement of Qualifications (Form F110-330) submitted in response to the RFQ, to indicate its intent to contract with and use EDGE-certified Business Enterprise(s), as a part of the A/E's team. The *Intent to Contract and to Perform* and / or waiver request letter and *Demonstration of Good Faith Effort* form(s) with complete documentation must be attached to the A/E's Technical Proposal. Both forms can be accessed via the OFCC website at <https://ofcc.ohio.gov>. The *Intent to Contract and to Perform* form is again required at the Fee Proposal stage.

If the A/E firm intends to receive points for exceeding the EDGE Participation Goal, it must provide BOTH a completed *Commitment to Participate* form AND a completed *Statement of Intent to Contract and to Perform* forms signed by both parties with its *Statement of Qualifications*.

For all *Statements of Qualifications*, please identify the EDGE-certified Business Enterprises by name, which will participate in the delivery of the proposed professional services solicited in the RFQ.

Interested A/E firms must indicate on their *Statement of Qualifications*, the locations where their services will be performed in the spaces provided or by attachment in accordance with the requirements of Executive Order 2019-12D related to providing services only within the United States and the requirements of Executive Order 2022-02D prohibiting purchases from or investment in any Russian institution or company. Failure to do so may cause their *Statement of Qualifications* to be rejected.

In Acrobat, go to Advanced, then PDF Optimizer. Also, please insert the project number and firm name followed by "SOQ" in the email subject line.

Statements of Qualifications must be submitted electronically by email. Submittals are limited to one email with a maximum file size of 25 MB.

Firms are requested to identify professional registrations, memberships and credentials including: LEED GA, LEED AP, LEED AP+, CCCA, CCM, CCS, CDT, CPE, DBIA, and any other appropriate design and construction industry credentials. Identify that information on the resume page for individuals in Block 22, Section E of the F110-330 form.
