

Ohio Facilities Construction Commission Construction Project Signage Standards

Updated: 05/23/2024

The Ohio Facilities Construction Commission (OFCC) Project Signage Standard has been developed to address the need for standardization of exterior project signage at construction sites around Ohio. The intent of this standard is to ensure that consistent information is being communicated and the signs have a visual consistency from project to project.

Project signs are required on all large Capital projects. Examples would be new buildings, significant additions to existing facilities, and major renovations. If the project is composed largely of interior renovations project signage may not be required.

Project Construction Sign

Graphic Image Panel shall be:

- 4'-0" high and 8'-0" in length, on .75" MDO wood board, primed and painted white with a graphic panel.
 - Print on 3M 180C control tac vinyl with UV inks, UV vinyl mounted on the MDO board, and wrap edges with vinyl
- 4'-0" high and 8'-0" in length, on Alupalite/AlumaCorr, white aluminum on both sides with a corrugated plastic core in the center
 - Print on matte cal vinyl, with UV ink and UV protectant laminate
- 4'-0" high and 8'-0" in length, or other "equivalent material" approved by the Contracting Authority

Provide and install two 4" x 4" x 12'-0" pressure treated posts and associated fasteners for attaching construction sign to posts.
