RATES: Electric \$31/night, Non-electric \$22/night + \$6.50 reservation fee

ALL CAMPSITES ARE RESERVABLE. Camp Host is located between sites 2 and 5.

PLEASE FOLLOW THE GUIDELINES BELOW TO ENSURE EVERYONE HAS A SAFE AND ENJOYABLE STAY

Check-in/Check-out Times: Campsite check-in time is 3 pm. Check-out time is 1 pm, at which time all camping equipment and vehicles must be removed from the site. For the Sherman Cabins the check-in time is 4 pm and check-out time is 11 am.

Sherman Cabins: Check-in time is 4 pm. Check-out time is 11 am. **No smoking inside the cabin.** Please do not burn candles/incense. No pets permitted in cabins.

Registration Age: Campers under the age of 18 must be accompanied by an adult.

Maximum Length of Stay: Maximum stay is 14 days within a 30-day period.

Maximum Number of People Per Site: Six people per site maximum. Events or parties over this limit are prohibited in the campground.

Tent Camping: Up to two sleeping tents are permitted per site without a camper vehicle, or one tent per site with a camper vehicle. Please camp only in the designated areas. Do not encroach on adjacent campsites.

Alcohol: Alcohol is permitted at your rented campsite only. All other Ohio Revised Code intoxicating beverage rules apply.

Campsite Parking Per Site: Campsites are permitted to have a maximum of two vehicles (a car/truck plus a trailer or RV) as space allows. For safety purposes, all parked vehicles must be kept clear of the roadway. Do not encroach on adjacent campsites.

Quiet Hours: Registered campers are responsible for maintaining quiet hours between 10 pm and 7 am. Generators may not be used during quiet hours.

Blackwater: Toilet wastewater must be disposed of at the waste dump station, located across from campground entrance.

Pets/Animals: Pets are permitted on all sites except Cabins. Two pets per site maximum. Animals are not permitted in any buildings. **PETS MUST BE ON A LEASH** in the camp area and on/off trails. All animals must be under control at all times. Owners should be prepared to show proof of vaccinations. **Pick up after your animals.** Do not leave your animals unattended.

Collecting: Collecting plants, or the cutting or gathering of trees or dead wood is against the law.

Campfires: Keep all fires contained and do not leave fires unattended. Firewood and ice can be purchased from camp staff.

Firearms/Fireworks: Use of firearms is prohibited in the campground. Fireworks are prohibited on state park property.

Trash: Please be kind to your natural resources. Please do not burn trash in the fire rings or on your site. Dumpsters are located near the campground entrance. Recycling cans are available near water building.

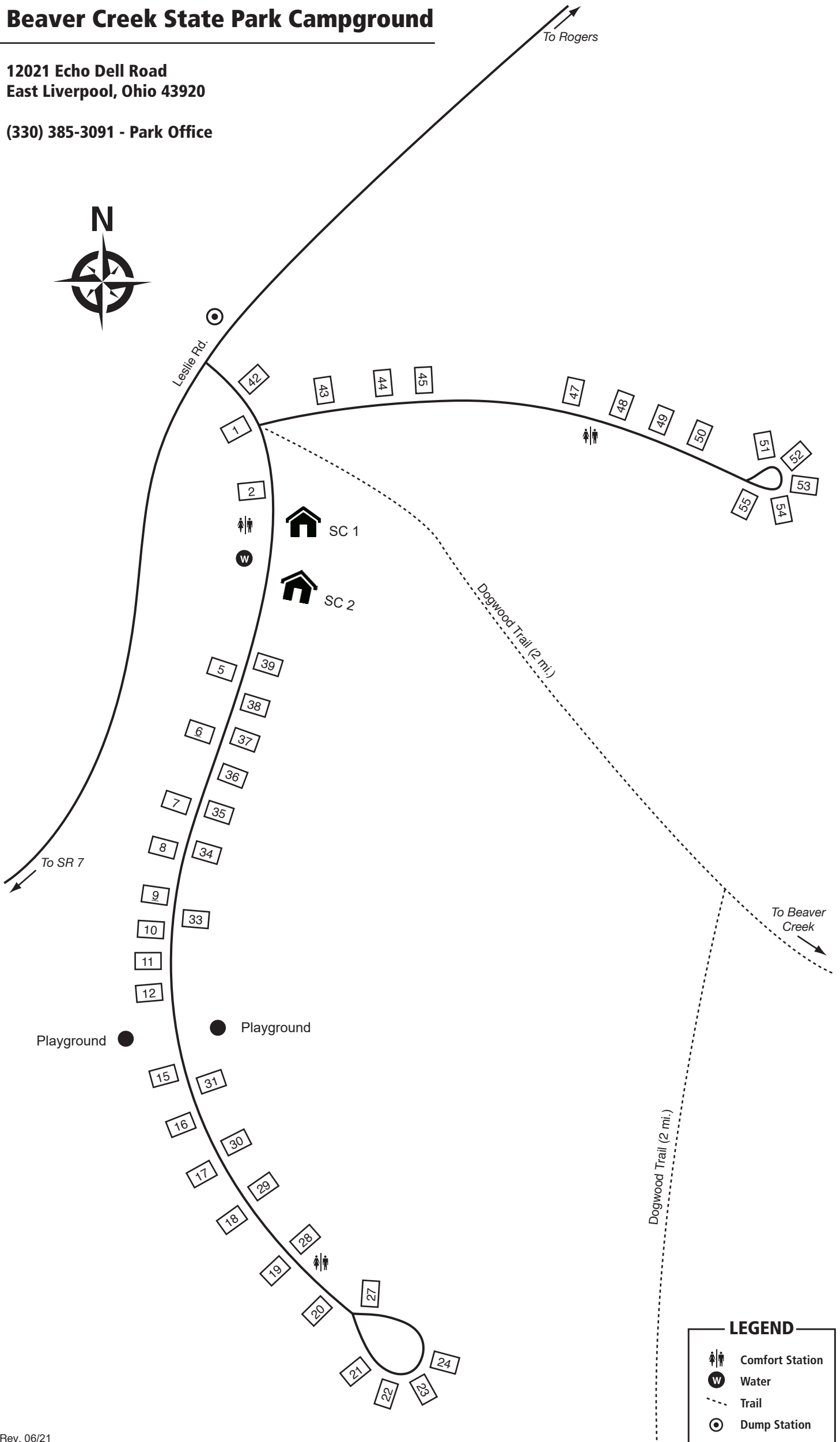
