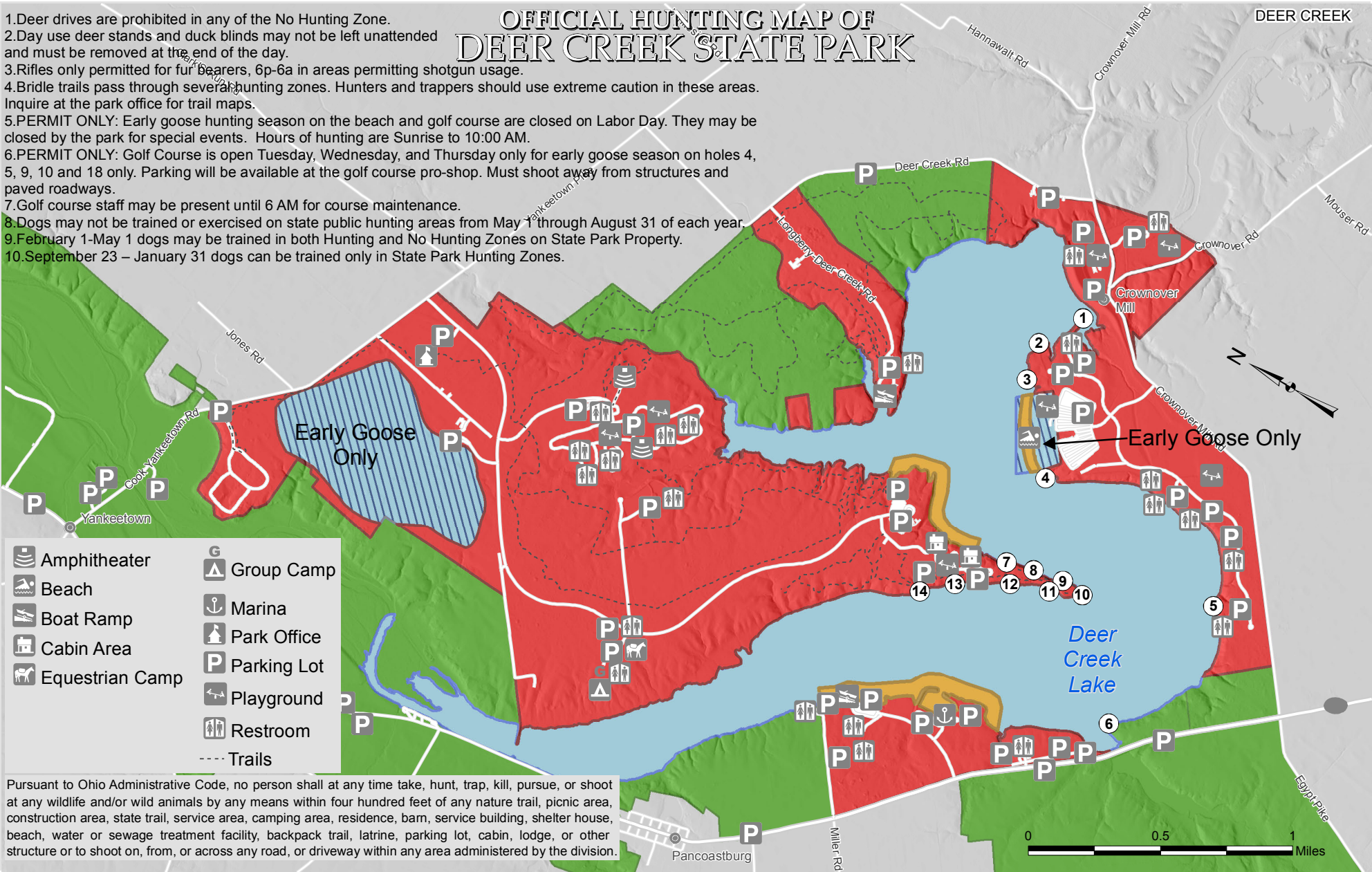


OFFICIAL HUNTING MAP OF DEER CREEK STATE PARK

1. Deer drives are prohibited in any of the No Hunting Zone.
2. Day use deer stands and duck blinds may not be left unattended and must be removed at the end of the day.
3. Rifles only permitted for fur bearers, 6p-6a in areas permitting shotgun usage.
4. Bridle trails pass through several hunting zones. Hunters and trappers should use extreme caution in these areas. Inquire at the park office for trail maps.
5. PERMIT ONLY: Early goose hunting season on the beach and golf course are closed on Labor Day. They may be closed by the park for special events. Hours of hunting are Sunrise to 10:00 AM.
6. PERMIT ONLY: Golf Course is open Tuesday, Wednesday, and Thursday only for early goose season on holes 4, 5, 9, 10 and 18 only. Parking will be available at the golf course pro-shop. Must shoot away from structures and paved roadways.
7. Golf course staff may be present until 6 AM for course maintenance.
8. Dogs may not be trained or exercised on state public hunting areas from May 1 through August 31 of each year.
9. February 1-May 1 dogs may be trained in both Hunting and No Hunting Zones on State Park Property.
10. September 23 – January 31 dogs can be trained only in State Park Hunting Zones.

Pursuant to Ohio Administrative Code, no person shall at any time take, hunt, trap, kill, pursue, or shoot at any wildlife and/or wild animals by any means within four hundred feet of any nature trail, picnic area, construction area, state trail, service area, camping area, residence, barn, service building, shelter house, beach, water or sewage treatment facility, backpack trail, latrine, parking lot, cabin, lodge, or other structure or to shoot on, from, or across any road, or driveway within any area administered by the division.
