MUTUALLY AGREED UPON EXCEPTIONS TO THE STANDARD TERMS AND CONDITIONS

<u>AFFIXATION OF INSIGNIA AND PATCHES:</u> The prices in this contract do not include the affixation of insignia and/or patches to garments. If at a point in the future the Agency determines it is necessary for the Contractor to affix patches and/or insignia to garments, the Contractor, DAS and the Ohio Department of Rehabilitation and Correction (ODRC) will determine prices for that service.

<u>ORDER PLACEMENT AND DELIVERY:</u> The prices in this contract apply to orders for garments which are summed at the location (institution) level by the ordering Agency and placed for delivery directly to the institution. The contractor will pick orders in bulk and ship them directly to the ordering institution for distribution by the institution to individual security officers. Prices in this contract do not include the picking of individual orders by wearer or the delivery of orders to any address other than the wearer's workplace (ODRC institution).

At a point in the future during the life of this contract, the Agency may determine to move to order placement and delivery by or to individual security staff. At that time the Contractor, DAS and ODRC will determine additional pricing necessary for the Contractor to provide that service.

* <u>DELIVERY TERM</u>: Galls, LLC-shall maintain inventory to fulfill orders as quickly as possible. Regularly stocked items; those up to and including size 4 Extra Large (4XL) shall be delivered to the ordering agency location between seven to thirty (30) days after receipt of order (ARO). Special cut items which are not stocked or may be out of stock consisting of sizes 5 Extra Large (5X) and larger and all long body short sleeve shirts and size 23 neck or larger long sleeve shirts may take up to 150 days after receipt of order (ARO) due to required manufacturing lead times. If Galls, LLC is not able to perform within the above delivery parameters, they will notify the ordering location of such after order placement and work out a mutually agreed delivery lead time.
