INSTRUCTIONS

Proof of financial responsibility may be shown by submitting \$30,000.00 in money for deposit with the Registrar of Motor Vehicles. All interest from the deposit will accrue to the General Fund of the State of Ohio and will not be paid to the applicant when the deposit is returned.

The following steps are required before proof of financial responsibility becomes effective:

1. The applicant shall complete the attached application and sign it in the presence of a notary public;
2. The applicant shall mail, at the applicants own risk, \$30,000 in the form of a certified check or cashier's check drawn upon an Ohio financial institution and payable to "Ohio Treasurer of State", along with the application to the Ohio Bureau of Motor Vehicles;
3. Upon receipt of the application and the \$30,000.00 in money, the Registrar of Motor Vehicles shall either approve or disapprove the application;
4. If approved, the Registrar shall deposit the money and shall execute a Certificate of Financial Responsibility, R.C. 4509.62;
5. The Registrar shall transmit the Certificate of Financial Responsibility, R.C. 4509.62 to the applicant;
6. The proof of financial responsibility becomes effective upon the Registrar's issuance of the Certificate.

The deposit of the money may be terminated upon written request only with the approval of the Registrar and only if they are satisfied that there are no claims against me pursuant to the provisions of R.C. Chapter 4509;

The deposit may be terminated by the Registrar for good cause at any time;

The money is tendered for the purpose of showing proof of financial responsibility for any motor vehicle operated by me and for any motor vehicle owned by me whether operated by me or by some other person with my permission, expressed or implied.
