- 5. Current original EPA Inspection Certificate or exemption FORM if required.

All vehicles up to 25 years old and owned by residents of the following counties are required to be tested: Cuyahoga Lake Medina Summit Geauga Lorain Portage

- 6. If registering a vehicle which is not a passenger or motorcycle for the first time, submit a BMV 5712.
- 7. If this is a leased vehicle, you must ALSO submit a Power of Attorney form and a copy of the lease agreement signed by the lease company (photocopies accepted; originals not returned) or your application will be returned to you unprocessed, unless electronically submitted.
