ARTICLE 27 WAGES

Section 1. Effective January 13, 2017 2019, bargaining unit employees shall receive a zero percent (0%) increase-a \$0.25 increase in their hourly rate of pay, as shown in Appendix B, Hourly Rates of Pay.

There shall be a wage reopener by ~~November 15th~~ for the second (2018) year and a wage reopener by ~~November 15th~~ for the third (2019) year of this Agreement.

Section 2. In the event the County Auditor implements a payroll system/pay stub that includes the employee's accumulated but unused vacation leave as well as the running total of vacation and sick leave used, the Employee's employees shall be included.

Section 3. Each member of the bargaining unit shall receive a five three hundred dollar (\$300.00) (\$500.00) lump sum payment payable upon the first pay period after ratification of this Agreement. This provision in Article 27, Section 3 shall expire automatically at the end of the term of this Agreement, unless the parties mutually agree to incorporate it into the successor wage reopener Agreement for the years 2018 and 2019.

Section 3. Effective December 15, 2019, bargaining unit employees shall receive a 2.25% increase in their hourly rate of pay, as shown in Appendix B, Hourly Rates of Pay.

Section 4. If the County Engineers gasoline tax income collections from October 2019 through March 2020 (6 months) exceeds \$600,000.00 net total increase over the same period from the previous year (year over year), each bargaining unit employee shall receive a 1.0% increase effect April 19, 2020 (paid on May 15, 2020 paycheck).

If the County Engineers gasoline tax income collections from October 2019 through March 2020 (6 months) exceeds \$500,000.00 net total increase over the same period from the previous year (year over year), each bargaining unit employee shall receive a 0.75% increase effect April 19, 2020 (paid on May 15, 2020 paycheck).

If the County Engineers gasoline tax income collections from October 2019 through March 2020 (6 months) exceeds \$400,000.00 net total increase over the same period from the previous year (year over year), each bargaining unit employee shall receive a 0.50% increase effect April 19, 2020 (paid on May 15, 2020 paycheck).

This provision in Article 27, Section 4 shall expire automatically at the end of the term of this Agreement, unless the parties mutually agree to incorporate it into a successor contract.
