#### **AGENDA**

The agenda for the October 25, 2022, regular board meeting was presented and reviewed.

#### Motion #1

Dr. Mills moved to accept the agenda. Ms. Hofbauer seconded the motion. The motion passed unanimously.

#### **MINUTES**

The minutes of the August 31, 2022 board meetings were reviewed.

#### Motion #2

Ms. Burton moved to accept the minutes of the August 31, 2022 board meeting. Ms. Hofbauer seconded the motion. The motion passed unanimously.

#### **BOARD PRESIDENT'S COMMENTS**

Tammy Brown welcomed everyone to the board meeting. She thanked the board members and the executive director for attending various state and national conferences in October, which included the Ohio School Speech Pathology Educational Audiology Coalition, Hearing Healthcare Alliance of Ohio, and the National Council of State Boards of Examiners for Speech-Language Pathology and Audiology. She thanked the board staff for their continued teamwork, cross-training, and processing of renewal applications.

### **FORMAL RULES HEARING – CHAPTER 119**

The Board held a R.C. Chapter 119 Rules Hearing at 10:00 a.m. There were no parties present to testify. The Board received written testimony in support of the proposed rules from the Hearing Healthcare Alliance of Ohio and entered it into the record as State's Exhibit B. The hearing concluded at 10:06 a.m.

The following rules are being proposed as amended rules:

4747-1-11 - Renewal Procedures

This rule specifies the licensure renewal requirements for hearing aid dealers, hearing aid fitters, and trainee permit holders. The Board is proposing to amend section (B)(2) clarifying that a trainee permit shall not be renewed to an individual more than one time, as specified under state law. The Board is also proposing to amend section (C) for the continuing education requirements for hearing aid dealers and fitters. The public purpose of this rule is to ensure licensees renew their license in a timely manner and maintain and develop their competency by completing continuing education.

#### 4747-1-14 - Trainees

This rule specifies the requirements for hearing aid trainee permit holders. The Board is proposing to amend section (B) by adopting a new sub-section (3) that will require the trainee permit holder to attest that the hearing aid trainee permit holder and supervisor have complied with all the supervision requirements under section 4747.10 of the Ohio Revised Code and this rule. The public purpose of this rule is to ensure consumer protection and that the trainee permit holder was appropriately supervised by a licensed hearing aid dealer or hearing aid fitter.

4747-1-15 - Fraud and/or misrepresentation, suspension, revocation or refusal of issuance of licenses and trainee permits

This rule specifies the grounds for disciplinary action for individuals or entities licensed under Chapter 4747. The Board is proposing to amend section (F) by removing references to "good moral character" requirements in accordance with House Bill 263 (133<sup>rd</sup> General Assembly).

### 4747-1-17 - Licensee responsibilities

This rule requires licensees to utilize appropriate hearing test procedures and maintain them on file for two years. The rule also requires licensees to notify the Board of any change to their contact information. The Board is proposing to amend section (B) that would require a licensed hearing aid dealer, firm, partnership, association, or corporation to notify the Board of any sale of its licensed hearing aid business no later than thirty days from the date of the sale. The public purpose of this rule is consumer protection by ensuring the Board can communicate with licensees.

### **ASSISTANT ATTORNEY GENERAL'S REPORT**

Principal Assistant Attorney General Crystal Richie indicated there were no legal issues or litigation involving the Board. She updated the Board on the impact of the U.S. Food and Drug Administration's (FDA) final rule on over-the-counter hearing aids to the Consumer Sales Practice Act, e.g., R.C. section 1345.30.

# **INVESTIGATIONS**

#### A. EXECUTIVE SESSION

#### Motion #3

Dr. Mills moved to enter Executive Session for the purpose of discussing investigation of charges or complaints against a licensee, regulated individual, or an applicant for the purpose of disciplinary action pursuant to R.C. §121.22.(G)(1), and which requires that such matters be kept confidential under R.C. §121.22(G)(5). Dr. Hofbauer seconded the motion, which passed by roll call vote as follows: Ms. Burton: yes; Mr. Cross: yes; Mr. Griffin: yes; Ms. Hofbauer: yes; Dr. Mills: yes; Mr. Pratt: yes; Dr. Spangler: yes; Mr. White: yes; and Ms. Brown: yes

The Board went into Executive Session at 10:30 a.m. and invited Board staff to remain in attendance. The Board also invited the Assistant Attorney General to remain in attendance.

#### B. BOARD ACTIONS

#### **New Cases**

### CO2021-16539, CO2021-16720, CO2021-17211

The above three cases involve a hearing aid fitter who was terminated from employment for violating company policy by not following hearing aid testing requirements and fitting protocols to several patients, e.g., shortened the length of time for hearing tests and did not perform masking.

During the interview the licensee admitted to the allegations. Their license was issued November 2011.

**Accordingly**, the Investigative Review Group (IRG) Committee recommends that the Board approve a Consent Agreement (Consent) with the following terms and conditions and to close the cases upon the licensee accepting and completing the terms. If the licensee does not agree to the terms of their Consent, the IRG recommends that the Board authorize a Notice of Opportunity for Hearing be issued:

- Reprimand;
- Take the Ohio Speech and Hearing Professionals Board's (Board) hearing aid fitter practical examination;
- Complete the Board's Laws & Rules examination

#### Motion #4

Mr. Cross moved to accept the IRG's recommendation in case numbers CO2021-16539, CO2021-16720, CO2021-17211. Dr. Hofbauer seconded the motion. Mr. Pratt abstained. The motion passed unanimously.

# **Continuing Education Audit 2019 – 2020**

A. FDA's Proposed Regulations on Over-the-Counter Hearing Aids
The Board discussed the U.S. Food and Drug Administration's final rules on over-the-counter
hearing aids. They also reviewed the FDA's letter of clarification issued on October 13, 2022,
which indicated that the final rule does not change the necessary qualifications of who may
provide hearing healthcare with prescription hearing aids. The FDA's letter also clarifies that the
final rule does not require an additional professional to take action, such as a physician's
involvement prior to fitting these devices, and does not require an examination to obtain a
prescription hearing aid. The Board also discussed topics for a FAQ.
