1099-NEC Upload Specifications

The specifications for tax year 2025 Form 1099-NEC, Nonemployee Compensation submitted in calendar year 2026, are contained in this document.

The Ohio Department of Taxation (ODT) follows the 1099-NEC layout required by the Internal Revenue Service in Publication 1220.

Ohio law requires <u>all</u> employers and retirement system payers to electronically file returns and submit income statements (W-2s & 1099-NECs) to the Department per Ohio Revised Code 5747.07, 5747.071 and Ohio Adminstrative Rule 5703-7-19. All employers and retirement system payers who file and pay their employer withholding taxes electronically will be required to upload their 1099-NEC information electronically through the Upload Income Statement feature on OH|TAX eServices. No paper IT 3 is required to be filed, the Upload Income Statement feature creates an IT 3 from the 1099-NEC information submitted.

You are required to maintain tax records, including 1099-NEC information, for a period of at least four (4) years from the due date. If the information is not submitted to the agency, ODT may request 1099-NEC information when conducting compliance programs.

Files must contain 1099-NEC information for each recipient from whom you withheld Ohio individual income tax or Ohio school district income tax during the reported year. The 1099-NEC information is not required to be submitted to the Department. if **NO** Ohio individual income tax or Ohio school district tax was withheld from their income.

The due date to file 1099-NECs is **February 2, 2026**.

This document is reissued every tax year and may be updated at any time to ensure that it contains the most current information.



What's New

Record Changes

For tax year 2025, there are no record layout changes.

Filing Reminders

- All employers and retirement system payers who file and pay their employer withholding taxes
 electronically will be required to upload their 1099-NEC information electronically through the
 Upload Income Statement feature on OH|TAX eServices.
- The file must only include 1099-NECs.
- Make sure that your data file is in text (.txt) format.
- The .txt extension must be in lowercase.
- Ohio does not accept files in a PDF format or files that were converted to text from a PDF format.
- File size limit is 100 MB.
- Ohio is not able to process data files in a .ZIP file format.
- All records must include an end of field distinction. This can be accomplished by inserting a Hard (Carriage) return/Line Feed at the end of the record.
- All records must have a FIXED length of 750 positions.
- Make sure each data file submitted is complete (T-A-B-B-B-C-K-F Records).
- Be sure to confirm that the tax year entered in the Issuer Record (A Record) is correct.
- Be sure the Employer Identification Number (EIN) is entered correctly in the Issuer Record (A Record).
- Do not use any FEINs in the name of the 1099-NEC file.
- Filing due date is February 2, 2026.

Submitting 1099-NEC Information to the State of Ohio

Upload 1099-NEC information using the link and instructions below.

- 1. Access the Employer Withholding panel on the dashboard, click the **Upload income statements (W2s, 1099s, etc.)** hyperlink located in the **Account** panel.
- 2. Select the **Wage and Income Statement** (1099-NEC) from the drop-down menu.
- 3. Click the **Next** button, the Upload File panel displays.
- 4. Click the **Upload File** button, the Select a file to attach window displays.
- 5. Click the **Choose File** button to browse your computer for the 1099-NEC file to be uploaded, click **Open** to upload the file.
- 6. Click the **OK** button. The Upload File window displays with a blue banner stating, **"There were no errors found with your file."**
- 7. Click the **Next** button, the Review window displays.
- 8. Click the **Submit** button, the file is now submitted.
- 9. The Confirmation screen displays. Click the **Printable View** button to print the confirmation page or click the OK button to return to the **Account Services** screen.
- 10. If there are errors within the file, an **Errors** window will appear providing the following information:
 - The number of errors within the file.
 - A description of the error.
 - The row and starting position of the error.
- 11. Once the errors are corrected, the file can be re-uploaded. Follow steps 1-9.



Data Requirements and Record Descriptions

Your 1099-NEC file must contain the following record types, which are described in detail in subsequent pages:

TRANSMITTER RECORD: Required.

CODE T

The CODE T record MUST be the FIRST data record on each file and identifies the organization transmitting the file.

ISSUER RECORD: Required.

CODE A

The CODE A record MUST be the SECOND data record on each file and identifies the issuer (the institution or person making payments), the type of document being reported and other miscellaneous information.

PAYEE RECORD: Required.

CODE B

The CODE B record is used to identify the payee, the specific payment amounts and information pertinent to the form.

SUMMARY OF ISSUER RECORD: Required.

CODE C

The CODE C record is used for the summary of payee "B" records and money amounts for each issuer per type of return.

SUMMARY OF STATE(S) TOTALS: Required.

CODE K

The CODE K record is used for the summary of state totals. Each state will have a separate "K" record.

TOTAL RECORD: Required.

CODE F

The CODE F record is the end of the transmission.



Transmitters of 1099-NEC information for multiple employers can avoid creating a separate file for each employer by arranging the records as shown in the following example:





























Transmitter "T" Record General Field Descriptions

The Transmitter "T" Record identifies the entity transmitting the electronic file. A replacement file will be requested if the "T" Record is not present.

- Transmitter "T" Record is the first record on each file and is followed by an Issuer "A"
 Record.
- All records must be a fixed length of 750 positions.
- Do not use punctuation in the name and address fields.
- The Transmitter "T" Record contains critical information used when it is necessary for ODT to contact the transmitter.
- For all fields marked "Required," the transmitter must provide the information
 described under General Field Description. For those fields not marked "Required," a
 transmitter must allow for the field but may be instructed to enter blanks or zeros in
 the indicated field positions for the indicated length.
- All alpha characters entered in the "T" Record must be upper case, except an email address which may be case sensitive.

Issuer "A" Record General Field Descriptions

The second record on the file must be an Issuer "A" Record.

The Issuer "A" Record identifies the person making payments. The issuer will be held responsible for the completeness, accuracy, and timely submission of electronic files. Examples of an issuer include:

- Recipient of mortgage payments
- · Recipient of student loan interest payments
- Educational institution
- Broker
- Person reporting a real estate transaction
- Barter exchange
- Creditor
- Trustee or issuer of any IRA or MSA plan
- Lender who acquires an interest in secured property or who has a reason to know that the property has been abandoned

A transmitter may include Payee "B" Records for more than one issuer in a file; however, each group of "B" Records must be preceded by an "A" Record and followed by an End of Issuer "C" Record. The Department of Taxation requests that only 1099-NECs are included in the file submitted to Ohio.

The number of "A" Records depends on the number of issuers. Do not submit separate "A" Records for each payment amount being reported. For example, if an issuer is filing Form 1099-NEC to report Amount Codes 1, and 4, both amount codes should be reported under one "A" Record, not four separate "A" Records.

The maximum number of "A" Records allowed in a file is 99,000. All records must be a fixed length of 750 positions. All alpha characters entered in the "A" Record must be upper case.

For all fields marked "Required," the transmitter must provide the information described under "General Field Description". For those fields not marked "Required," a transmitter must allow for the field, but may be instructed to enter blanks or zeros in the indicated field position(s) and for the indicated length.

Payee "B" Record General Field Descriptions

The "B" Record contains the payment information from information returns.

- The record layout for field positions 1 through 543 is the same for all types of returns.
- Field positions 544 through 750 vary for each type of return to accommodate special fields for individual forms.
- Allow for all 18 Payment Amount Fields. For the fields not used, enter "0" (zeros).
- All records must be a fixed length of 750 positions.
- All alpha characters must be upper case.
- Do not use decimal points (.) to indicate dollars and cents.

For all fields marked "**Required**," the transmitter must provide the information described under "General Field Description." For those fields not marked "**Required**," the transmitter must allow for the field, but may be instructed to enter blanks or zeros in the indicated field position(s) and for the indicated length.

A field is also provided for Special Data Entries. This field may be used to record information required by state or local governments, or for the personal use of the filer. The IRS does not use the data provided in the Special Data Entries Field; therefore, the IRS program does not check the content or format of the data entered in this field. It is the filer's option to use the Special Data Entries Field.

Following the Special Data Entries Field, payment fields have been allocated for State Income Tax Withheld and Local Income Tax Withheld. The information is not used by the IRS but is required by the Ohio Department of Taxation.

For example: For Form 1099-NEC reporting 12,000,000,000.00, the first "B" record would show 8,000,000,000.00 and the second "B" record would show 4,000,000,000.00.
