# **Chapter 1 – Introduction**

#### General

This guide contains the general instructions needed to file motor fuel tax returns electronically with the Ohio Department of Taxation. This guide is designed to provide the rules, procedures, and reference to the technical requirements for the electronic filing of motor fuel taxes.

# **Chapter 2 - Program Overview**

ODT has designed this process, integrating it into the Ohio Business Gateway (OBG), to provide an electronic filing and payment solution for all Ohio Motor Fuel Tax filers. Advantages of participating in ODT electronic filing and payment program:

- o New reporting requirements are supported by the XML file format
- o Proper formatting and strict adherence to these guidelines are necessary for successful electronic filing
- o Electronic filing ensures secure movement of data allowing for faster processing and response
- o Comprehensive audit trail for both the return and payment
- o A consistent, standard format, resulting in easier implementation efforts

The Department supplies filing specifications (XML) to filers, and it is the responsibility of industry to update software to match the state's specifications. The filer is also given the option to use ASCII to file. See the ASCII guide for information in this file format.

#### **Schedule Changes**

The following represent changes/updates to the schedules utilized for the motor fuel dealer return:

- Schedule 4 represents fuel that is produced (i.e., ethanol, biodiesel) and has a Mode of PR. Gallons must represent what is produced. XML Files now accept Schedule 4s with a Mode of PR.
- Schedule 5AD represents disbursements of fuel for retail sales only. A retailer's Ohio Account Number is required to file disbursements to a retailer. The schedule will be used to calculate retail shrinkage for the fuel dealer and to provide documentation for the retail shrinkage refund.
- o Schedules 14a, 14B, and 14C represent fuel that is transported for others. A separate transporter's license is no longer necessary.
- o Schedule 10B now requires the fields of Destination City, Destination State, and Destination County to be present to be accepted.
- o All schedules now require the use of a 2-digit county code when reporting a county in the State of Ohio.
- Diversion Number and Import/Export Registration Number fields are now accepted.

The following represent changes/updates to the schedules utilized for the motor fuel terminal operator return:

- Schedule 15A represents fuel receipts, replacing 2A.
- Schedule 15B represents fuel disbursements, replacing 4A.
- o All schedules now require the use of a 2-digit county code when reporting a county in the State of Ohio.

The following represent changes/updates to the schedules utilized for the motor fuel exporter return:

- Schedule 1B represents fuel received for export, destination state tax paid.
- o Schedule 2E represents fuel received for export, destination state tax not paid.
- o Schedule 7A represents fuel exported, destination state tax paid.
- o Schedule 7D represents fuel exported, destination state tax not paid.
- o All schedules now require the use of a 2-digit county code when reporting a county in the State of Ohio.
- Diversion Number and Import/Export Registration Number fields are now accepted.

The following represent changes/updates to the schedules utilized for the motor fuel transporter return:

- o Schedule 14A represents gallons loaded at an Ohio terminal or bulk plant and delivered to another state, replacing schedule 1A (exports).
- o Schedule 14B represents gallons loaded at an out-of-state terminal or bulk plant and delivered to Ohio, replacing schedule 2A (imports).
- o Schedule 14C represents gallons loaded at an Ohio terminal or bulk plant and delivered to Ohio, replacing schedule 3A (intrastate).
- o All schedules now require the use of a 2-digit county code when reporting a county in the State of Ohio.
- Diversion Number and Import/Export Registration Number fields are now accepted.

#### **Filing Requirements**

Pursuant to Ohio Administrative Code <u>5703-11-04</u>, all Ohio Motor fuel tax taxpayers must file and pay electronically effective November 1, 2015. Each account will be assigned an ODT account number. This number will be required to file all tax reports.

Returns supported by the XML format:

- Fuel Dealer (MF-2)
- Exporter (EX-2)
- Transporter (TR-2)
- Terminal Operator (TO-2)

Fuel Dealer (MF-2) - 5735.06 Motor fuel dealer to file monthly report - contents of report.

(A) On or before the last day of each month, each motor fuel dealer shall file with the tax commissioner a report for the preceding calendar month, on forms prescribed by or in a form acceptable to the tax commissioner.

Exporter (EX-2) – 5735.064 Exporter's report.

(A) On or before the last day of each month, each exporter of motor fuel, licensed under section <u>5735.026</u> of the Revised Code, shall file with the tax commissioner a report for the preceding calendar month on forms prescribed by or in a form acceptable to the tax commissioner.

Transporter (TR-2) – <u>5735.09</u> Registration of Transporters; reports.

(A) Each transporter shall report all deliveries of motor fuel made to points in this state to the commissioner on forms prescribed by the commissioner. Such reports shall cover monthly periods, shall be submitted within thirty days after the close of the month covered by the report.

Terminal Operator (TO-2) – <u>5735.063</u> Terminal operator to file monthly report - contents of report.

(A) On or before the last day of each month, each terminal operator shall file with the tax commissioner a report for the preceding calendar month on forms prescribed by or in a form acceptable to the tax commissioner.

#### **Amended Returns**

Amended returns must be filed in the same manner as the original return. Original returns that were filed electronically must be amended electronically. Electronic amendments should provide all schedule detail records.

The "Reason for Amending Report" field must specify the word "Supplemental" to assure the file will be accepted as an amended return.

# **Acceptable Electronic Formats**

ODT will only accept electronic motor fuel tax returns filed electronically through The Ohio Business Gateway. Once loaded, the filer will view the returns on-line and make their tax payment.

#### **Ohio Business Gateway**

Electronic filing will require registration for each account through the Ohio Business Gateway. Login if you have an existing account or click "Create an account" to get started. For help, click on "Help/Tutorials/Telephone Support".

#### **File Requirements**

File requirements for XML can be found at <a href="http://www.tax.ohio.gov/excise/motor\_fuel.aspx">http://www.tax.ohio.gov/excise/motor\_fuel.aspx</a>. The XML schema package contains an Excel document entitled "ODT Motor Fuel XPATH Documents January2018.xlsx". This document provides details for the Header, Operator (Terminal Operator), Distributor (Fuel Dealer and Exporter), and Carrier (Transporter).

#### **Upload Constraints**

- If you have more than one file, the files must be uploaded individually but within the same transaction. Additional files cannot be added at a later time or date
- o File validation occurs nightly. The file(s) will be ready for the next step within 24 hours.
- o Acceptable electronic filing methods are text (ASCII) and XML.
- o All \*.xml files MUST be compressed, only compressed files (\*.zip) format will be accepted for upload.
- Each file uploaded cannot exceed 5,120 KB or 5 MB in size. Files larger than this must be split into two, or compressed to reduce file size.
- o Compressed files (\*.zip) may only contain a single file. Compressing more than one file in the same archive will cause file validation to fail.

#### **Important Tips**

- o The system will summarize the gallons based on product type and schedule type to determine total tax due.
- o Filing is by account number provided by ODT.
- All fuel reported should be identified by product codes on the appropriate schedule, round to whole gallons
  - o Decimal points are not valid in the gallon fields
  - o Round down all amounts less than .50 and round up all amounts of .50 or greater
- o Electronic returns must be received by the due date to be considered timely
- o If you pay by ACH Credit, the payment has to be received by the due date of the return to be considered timely paid.
- o As a result of the processing time, please allow ample time for your return and payment to be posted by the appropriate due date.

#### **ODT Inventory**

Dealer inventory must be reported within the MFDistributorReport.xsd and is located using the following X path:

MotorFuelsFiling/DistributorReport/DistributorReportDetails/Inventory/. The value(s) is representative of gross gallons by product type. Note that beginning and ending inventory are both required.

Terminal operator inventory must be reported within the MFTOReport.xsd and is located using the following X path:

MotorFuelsFiling/TerminalOperatorReport/TerminalReportDetails. The value(s) is representative of net gallons by product type. Note that beginning and ending inventory are both required.

Schedule 15C is not an acceptable schedule for xml format.

#### **ODT Record Count**

The record count field is contained within the MotorFuelsTransmissionHeader.xsd and is located using the following X path: Transmission/TransmissionHeader/attributes/recordCount. This value is representative of the sum of both the following:

- All Distributor, Terminal Operator, and Carrier Schedules
- All Inventory nodes included in the Distributor or Terminal Operator the total number of receipts, disbursements and inventories reported.

#### **Book Adjustment Codes**

Transfers within a bulk plant from one product type to another product type must be accounted for on the receipt (Dealer Schedule 2 or Terminal Operator Schedule 15A) and disbursement (Dealer Schedule 6 or Terminal Operator Schedule 15B). List on the disbursement schedule indicating the "book adjustment" code (from the table below) where the product is being disbursed to, and list on the receipts schedule the "book adjustment" code where the product is being received from in. The mode of transportation is always BA. Complete other fields as required.
