#### **Backflow Technician Certification Classification**

Three classes of backflow technician certifications may be issued by the Division:

- Class A certified backflow technicians are authorized to perform installation, testing, or repair of <u>any isolation backflow prevention device in the state.</u>
- Class B certified backflow technicians are authorized to perform installation, testing, or repair of any isolation backflow prevention device in the state <u>located within</u> a lawn irrigation process piping system.
- Class C certified backflow technicians are authorized to perform installation, testing, or repair of any isolation backflow prevention device in the state <u>that is owned</u> by the public water system.

### **Work Experience**

- <u>Class A Applicants:</u> Employment with a <u>licensed</u> Plumbing Contractor, Hydronics Contractor, or Fire Protection Company certified by the Ohio State Fire Marshal.
- Class B Applicants: Employment with a Lawn Irrigation Company.
- <u>Class C Applicants:</u> Employment with a Water Purveyor.

You must provide copies of your tax records (e.g., W-2s, 1099, Schedule C Form 1040) or other acceptable documentation (e.g., Ohio journeyperson license/card, degree certificate, school transcript, certificate of completion, etc.) demonstrating at least 5 years' total experience to assist with verification of your experience and education.

### **Backflow Technician Certification Application Process**

- Applicant uploads the application to the <u>Commerce Web Portal</u> or emails application to the Division of Industrial Compliance and pays a one-hundred dollar (fifty dollar application fee + fifty dollar examination fee) non-refundable fee <u>online</u>.
- Application is reviewed by the Superintendent's Designee and/or the Division's Licensing Section and a determination is made on the application.
  - Please Note: Applications may be presented to the Backflow Advisory Board for a determination on the application. The Backflow Advisory Board meets quarterly (March, June, September, and December).

#### Decision:

- Approved: an approval letter will be submitted to the applicant along with a list of training agencies approved for required backflow technician training.
- More Information Needed: applicant will be contacted to request additional information if the Superintendent's Designee/Section finds the application fails to provide sufficient information to make a determination.
- Denied: if the applicant fails to demonstrate sufficient experience to meet the requirements for certification as a backflow technician under Rule <u>1301:3-7-02</u> of the Ohio Administrative Code, a denial letter will be submitted to the Applicant.
- Backflow Technician Training Course(s)
  - Approved applicants attend one of the authorized backflow technician training courses.
  - Upon successful completion of the course, the applicant will receive a certificate of proficiency from the course administrator.
- Backflow Technician Examination
  - o Date:
    - The Backflow Technician Examination is generally given on the 3<sup>rd</sup> Monday of the month, unless a holiday falls on or is being observed on that day. In which case the examination will be given on the following day. Please visit the <u>Backflow Technician Exam</u> page of our website for a list of available exam dates.
  - Location:

    - Doors will open at 9:30 A.M. with the test beginning at 10:00 A.M. and ending at 12:00 P.M.; or
    - Doors will open at 12:30 P.M. with the test beginning at 1:00 P.M. and ending at 2:00 P.M.

- Requirements on day of examination:
  - Examinees **MUST** bring the following on the day of the test:
    - Certificate of proficiency
    - Photo identification
- Passage criteria:
  - A score of 70% or higher on the examination is required to pass.
    Examinees will be notified of the results of the examination by letter.
- Certification Fee:
  - Individuals that pass the examination will receive an invoice for the \$75.00 certification fee. Upon payment of the certification fee, a 3-year Backflow Technician Certificate will be issued to the individual and it will also be added to their portal (available online).
