

**CONSENT AGREEMENT
BETWEEN
GEHAN ALY EMARA-JALLAQ, D.D.S.
AND
THE OHIO STATE DENTAL BOARD**

This CONSENT AGREEMENT is entered into by and between, GEHAN ALY EMARA-JALLAQ, D.D.S., (DR. EMARA-JALLAQ), and THE OHIO STATE DENTAL BOARD, (BOARD), the state agency charged with enforcing the Dental Practice Act, Chapter 4715 of the Ohio Revised Code (ORC).

DR. EMARA-JALLAQ voluntarily enters into this AGREEMENT being fully informed of her rights under Chapter 119, Ohio Revised Code, including the right to representation by counsel and the right to a formal adjudication hearing on the issues considered herein.

This CONSENT AGREEMENT is entered into on the basis of the following stipulations, admissions and understandings:

- A. The OHIO STATE DENTAL BOARD is empowered by Section 4715.30, ORC, to limit, revoke, suspend a certificate or license, refuse to register or reinstate an applicant, or reprimand or place on probation the holder of a certificate or license. Section 4715.30 [REDACTED], ORC, authorizes the Board to discipline a licensee for [REDACTED]

- B. DR. EMARA-JALLAQ is currently certified to practice dentistry in the State of Ohio, License No. 30.022243.

- C. DR. EMARA-JALLAQ knowingly and voluntarily admits to the following:

- D. The OHIO STATE DENTAL BOARD enters into this CONSENT AGREEMENT in lieu of formal proceedings based upon any alleged violations of Section 4715.30 [REDACTED], ORC. The BOARD expressly reserves the right to institute formal proceedings based upon any other violations of Chapter 4715 ORC, whether occurring before or after the effective date of this CONSENT AGREEMENT.

AGREED CONDITIONS

WHEREFORE, in consideration of the foregoing and mutual promises hereinafter set forth, and in lieu of any further formal proceedings at this time, DR. EMARA-JALLAQ knowingly and voluntarily agrees with the BOARD, to the following terms, conditions, and limitations:

PROBATIONARY PERIOD

DR. EMARA-JALLAQ's credentials shall be suspended indefinitely. Such suspension shall be stayed subject to the following Probationary Terms and Restrictions for a minimum period of two (2) years.

1. DR. EMARA-JALLAQ shall obey all federal, state, and local laws.
2. DR. EMARA-JALLAQ shall obey all laws and rules governing the practice of dentistry in Ohio.
3. DR. EMARA-JALLAQ shall appear in person before the BOARD or its designated representative, as directed by the BOARD.
4. 
5. DR. EMARA-JALLAQ shall successfully complete ten (10) hours of continuing education in the area of ethics. The education must be taken through a BOARD approved provider and must be approved in advance by the BOARD's Supervisory Investigative Panel (PANEL). Proof of successful completion of courses required in this paragraph shall be submitted to the PANEL within one hundred eighty (180) days from the date this CONSENT AGREEMENT is ratified by the BOARD. The continuing education hours shall not count towards the continuing education requirements set forth in section 4715.141, ORC.
6. DR. EMARA-JALLAQ shall report to the BOARD, within one (1) business day, any violation of the conditions of community control imposed by the court.
7. Within seven (7) days of the effective date of this CONSENT AGREEMENT, DR. EMARA-JALLAQ agrees to provide her current employer(s) with a copy of this CONSENT AGREEMENT. DR. EMARA-JALLAQ is under a continuing duty to provide a copy of this CONSENT AGREEMENT to any new employer(s) prior to accepting employment.

8. DR. EMARA-JALLAQ shall submit monthly declarations, to be received by **the fifth day of each month**, under penalty of BOARD disciplinary action stating whether there has been compliance with all the conditions of this CONSENT AGREEMENT.
9. In the event DR. EMARA-JALLAQ is found by the PANEL to have failed to comply with any provision of this CONSENT AGREEMENT, and is so notified of that deficiency in writing, such periods of noncompliance will not apply to the reduction of the probationary period under this CONSENT AGREEMENT.
10. In the event that DR. EMARA-JALLAQ should leave Ohio for three (3) continuous months, or reside or practice outside the state, DR. EMARA-JALLAQ must notify the BOARD in writing of the dates of departure and return. Periods of time spent outside Ohio will not apply to the reduction of this probationary period under the CONSENT AGREEMENT, unless otherwise determined by motion of the BOARD in instances where the BOARD can be assured that probationary monitoring is otherwise being performed.
11. DR. EMARA-JALLAQ agrees that her license to practice dentistry may be automatically suspended if DR. EMARA-JALLAQ has violated or breached any terms or conditions of this CONSENT AGREEMENT. Following the automatic suspension, the BOARD shall notify DR. EMARA-JALLAQ via certified mail of the specific nature of the charges and automatic suspension of DR. EMARA-JALLAQ's license to practice dentistry. If, in the discretion of the BOARD, DR. EMARA-JALLAQ appears to have violated or breached any terms or restrictions of this CONSENT AGREEMENT, the BOARD reserves the right to institute formal disciplinary proceedings for any and all possible violations or breaches, including, but not limited to, alleged violations of the laws of Ohio occurring before the effective date of this CONSENT AGREEMENT.
12. Upon successful completion of her probationary terms, DR. EMARA-JALLAQ must appear before the BOARD or its designee before the BOARD will fully restore DR. EMARA-JALLAQ's license to practice dentistry.

DURATION/MODIFICATION OF TERMS

The terms and restrictions of this Consent Agreement may be modified or terminated, in writing, at any time upon the agreement of both DR. EMARA-JALLAQ and the BOARD.

The BOARD may only alter the probationary period imposed by this Consent Agreement if: (1) the Board determines that DR. EMARA-JALLAQ has complied with all aspects of this Consent Agreement; and (2) the BOARD determines that DR. EMARA-JALLAQ is able to practice dentistry according to accepted standards of the profession without BOARD monitoring, based upon an interview with DR. EMARA-JALLAQ by the BOARD or its designee.

ACKNOWLEDGMENTS/LIABILITY RELEASE

Any action initiated by the BOARD based on alleged violations of this CONSENT AGREEMENT shall comply with the Administrative Procedure Act, Chapter 119, ORC.

DR. EMARA-JALLAQ acknowledges and understands that this CONSENT AGREEMENT shall be considered a public record as that term is used in Section 149.43, ORC, and may be reported to any appropriate data bank or reporting agency. DR. EMARA-JALLAQ acknowledges that her social security number will be used if the information is so reported, and DR. EMARA-JALLAQ agrees to provide her social security number to the BOARD for such purposes.

DR. EMARA-JALLAQ, with the intention of binding herself and her successors in interests and assigns, holds harmless from liability and forever discharges the State of Ohio, the BOARD, and any of their members, officers, attorneys, agents, and/or employees, personally or in their official capacities, from any and all claims that were raised or could have been raised in or relating to this matter, including but not limited to costs, expenses, attorney fees and/or all other damages.

DR. EMARA-JALLAQ acknowledges that she has had adequate opportunity to ask questions concerning the terms of this CONSENT AGREEMENT and that all questions asked have been answered in a satisfactory manner.

WHEREFORE, in consideration of the mutual promises contained herein, and subject to the conditions and limitations stated herein, the BOARD hereby foregoes any disciplinary proceeding against DR. EMARA-JALLAQ pending successful completion of these terms and conditions.




