GENERAL

CASE MANAGEMENT TASKFORCE. The taskforce is commissioned to look at the current procedures and processes for investigating cases and to develop a resolution that can be implemented to allow for a more streamlined handling of cases to process them more efficiently, with more ease, and without negatively impacting the integrity of the investigation process. The task force had its first meeting on November 9th. The task force will meet for two consecutive days to allow time for the development of a new complete process.

OCRC ACADEMY. On November 6th and 7th, OCRC held its second annual Academy. This is a two-day training was on how to navigate the Commission.
