GENERAL

MANDATORY TRAINING. On Wednesday April 24 at 10:00 a.m. Bradley Dunn will give an Implicit Bias training for the entire OCRC staff. A TEAMS invite has already been issued. If any Commissioner wants to attend the training, please let me know and I will make sure that you receive an invite.

EXTERN PROGRAM. The extern program is to offer experience to students that will help them to not only gain knowledge about the mission of the commission and the process to carry out that mission, but it is also to help students develop certain skill sets and to challenge existing skills. This is valuable to the participants as well as to the Commission. The program serves another form of community outreach to enhance the Commission's presence.

ODOT CIVIL RIGHTS SYMPOSIUM. On April 9th, Director Phelps-White, Chief Administrative Law Judge Johnson, and Administrative Law Judge Dunn, gave a workshop at the invitation of ODOT on Update on Civil Rights in Ohio and The Supreme Court Decision on Affirmative Action and the Aftermath. Both topics were well received, and the organizers of the symposium were appreciative of our continued support of their event.

GLOBAL LEADERSHIP PROJECT. On April 11th, Director Phelps-White spoke to the students participating in the Global Leadership Project. The students were engaged and inquisitive. Their questions demonstrated their acute awareness of what is currently happening in our society today. The following two posts were on Linked In from a couple of the participants:

Tyler Crowder:

Today during my Columbus field trip with the Global Leadership Project, I visited the Ohio Civil Rights Commission. There I heard from guest speaker Angela Phelps-White who spoke about what the OCRC does and other things. The OCRC deals with "human to human relations" and takes cases to dispute them. They are stationed in 5 regions: Akron, Columbus, Cleveland, Dayton-Cincinnati, and Toledo. Their 3 primary functions are hashtag#Investigation, hashtag#Mediation, and hashtag#Education. Angela also talked about hashtag#discrimination, hashtag#diversity, and hashtag#equity. She described how important not only diversity, but equity, treating everyone fairly and impartially, is to life and society. She tells how there is a difference between hashtag#equality, and equity and uses the following analogy to differentiate them, equality is everyone having the exact same bike, while equity is everyone having the bike that works best for them. To end off, my takeaway from this experience that I will apply is a quote from Angela "It is not our differences that divide us, it is our inability to recognize, accept, and celebrate those differences."

Trinity Anderson:

For my Global Leadership class today we took a field trip to the Ohio Civil Rights Commission and met with the Executive Director Angela Phelps-White. She showed a power point teaching about what they do and defining discrimination. I learned about the steps they take when someone has been discriminated against. hashtag#investigation, hashtag#mediation, and hashtag#education. What I learned most was how many different ways someone can be discriminated against. There are so many different groups. Race, sex, medically, mentally, military, age, disability, etc. I have faced discrimination in my life and I feel like people need to be educated on what other people need and have hashtag#empathy and hashtag#Inclusion which was also discussed. Now going forward I'm going to be more inclusive because having people like that in life can teach me new things.

OHIO WOMEN BAR ASSOCIATION ANNUAL MEETING AND CONFERENCE. On April 12th, Director Phelps-White was on a panel discussing Alternative Dispute Resolutions. The panel discussed mediations, arbitrations, and other methods of dispute resolutions in the court system and the administrative process. The panelists included Former Ohio Supreme Court Justice Eve Stratton and Professor Sarah Rudolph Cole.


