

### **Adult Day Support**

*"Adult day support" means provision of regularly scheduled activities in a non-residential setting, such as assistance with acquisition, retention, or improvement of self-help, socialization, and adaptive skills that enhance the individual's social development and performance of daily community living. Adult day support shall be designed to foster the acquisition of skills, build community membership and independence, and expand personal choice. Adult day support enables the individual to attain and maintain his or her maximum potential.*

- ✓ Supports the individual's membership in the community
- ✓ Enhances opportunities for community membership, personal growth, independence, and natural supports
- ✓ Can include volunteer opportunities
- ✓ Can be used for when individuals are not at work

### **Homemaker/Personal Care**

*"Homemaker/Personal Care" means the coordinated provision of a variety of services, supports, and supervision necessary to ensure the health and welfare of an individual who lives in the community. Homemaker/personal care advances the individual's independence within his or her home and community and helps the individual meet daily living needs. Examples of supports that may be provided as homemaker/personal care include:*

- Self-advocacy training to assist in the expression of personal preferences, asserting individual rights, and making increasingly responsible choices.
- Self-direction, including the identification of and response to dangerous or threatening situations, making decisions and choices affecting the individual's life, and initiating changes in living arrangements and life activities.
- Daily living skills including training in and providing assistance with routine household tasks, meal preparation, personal care, self-administration of medication, and other areas of day-to-day living.
- Medical and health care services that are integral to meeting the daily needs of the individual
- Community access services that explore community services available to all people, natural supports available to the individual, and develop methods to access additional services, supports, and activities needed by the individual to be integrated in and have full access to the community.

## Vocational Habilitation

## Group Employment Supports

"Group Employment Supports" means services and training activities provided in regular business, industry, and community settings for groups of two or more workers with disabilities.

- ✓ Supports the individual's community employment goals
- ✓ May be one larger group that separates into many small groups at one location
- ✓ May be one small group that travels to many different locations
- ✓ Promotes interactions between participants and people without disabilities in an integrated setting

**What activities can be included in Group Employment Supports?** (See rule definition for full description)

- Employment Planning
- Work Adjustment
- Job analysis
- Training and systematic instruction
- Job Coaching
- Benefits support
- Transportation training, planning and arranging
- Career advancement services

## Career Planning

"Career planning" means individualized, person-centered, comprehensive employment planning and support that provides assistance for individuals to achieve or advance in competitive integrated employment. Career planning is a focused and time-limited engagement of an individual in identification of a career direction and development of a plan for achieving competitive integrated employment and the supports needed to achieve that employment.

- ✓ Are provided one-on-one
- ✓ Support a person's community employment goals
- ✓ Designed to develop an individualized employment plan
- ✓ Designed to gather information about a person's strengths, interests, and employment preferences
- ✓ Can lead directly to individualized employment through job development
- ✓ Can be provided in conjunction with other services

- Situational observation and assessment
- Career exploration
- Benefits education and analysis\*
- Career discovery
- Employment/self-employment plan
- Job development
- Self-employment launch
- Worksite accessibility\*
- Assistive technology assessment\*

## Individual Employment Support

"Individual employment support" means individualized support for an individual to maintain competitive integrated employment.

- ✓ Are provided one on one
- ✓ Supports an individual in maintaining or advancing in current competitive employment
- ✓ Promotes interactions between participants and people without disabilities in an integrated setting

### What activities can be included in Individual Employment Supports?

- Assistive technology training
