

**PERMANENT VOLUNTARY RETIREMENT
OF THE LICENSE TO PRACTICE DENTISTRY IN THE STATE OF OHIO**

Do not sign this agreement without reading it. An individual who retires a license or certificate issued by the Board is thereafter ineligible to hold a license/certificate/registration to practice or to apply to the Board for reinstatement of the license/certificate/registration. You are permitted to be represented and advised by an attorney, at your own expense, before deciding to sign this voluntary agreement.

I, MARGARET L. PALMER, D.D.S., am aware of my right to representation by counsel, the right to be formally charged and have a formal adjudicative hearing, and do hereby freely execute this document and choose to take the actions described herein.

I, MARGARET L. PALMER, D.D.S., wish to retire from the practice of dentistry in the State of Ohio and do hereby voluntarily, knowingly, and intelligently permanently retire my license to practice dentistry, License No. 30.020689, to the Ohio State Dental Board ("Board"), thereby relinquishing all rights to practice dentistry in Ohio.

I understand that as a result of the permanent voluntary retirement herein that I am no longer permitted to practice dentistry in any form or manner in the State of Ohio.

I agree that I shall be ineligible for, and shall not apply for, reinstatement or restoration of my license to practice dentistry, License No. 30.020689, or issuance of any other license pursuant to chapter 4715, Ohio Revised Code, on or after the last date of signature below of this Permanent Voluntary Retirement of the License to Practice Dentistry in the State of Ohio. Any such attempted re-application shall be considered null and void and shall not be processed by the Board.



I, MARGARET L. PALMER, D.D.S., hereby release the Board, its members, employees, attorneys, agents, officers, and representatives jointly and severally from any and all liability arising from the within matter.

Further, this information may be reported to appropriate organizations, data banks and governmental bodies. I, MARGARET L. PALMER, D.D.S., acknowledge that my social security number will be used if this information is so reported and agree to provide my social security number to the Board for such purposes.
