Dear Director Wente:

H.B. 33 of the 135<sup>th</sup> General Assembly transferred rulemaking responsibilities regarding children services from the Department of Education and Workforce, the Department of Health, the Department of Job and Family Services, and the Department of Developmental Disabilities to the newly created Department of Children and Youth. Section 423.140 of that act authorizes the Director of the Legislative Service Commission to renumber existing rules to reflect the transfer of authority and responsibility to the Department of Children and Youth.

This is to notify you that, pursuant to that grant of authority and at your request, I hereby renumber the following administrative rules:
