

Common Errors – All Filers







Basic Filing Information

- eServices
- Match taxable sales and tax liability
- Exempt
- Clerk of Courts
- Accelerated payments
- Only need to register once, not annual
- \$0 sales, filing still required

Basic Filing Information

- Amendment replaces original filing
- Sales tax monthly deadlines
 - 23rd of the following month
- Sales tax semi-annual deadlines
 - July 23
 - January 23
- \$200 threshold
- Discount 0.75%
- COTA increase effective 4/1/2025






Electronic Filing Errors

- Return payment
- Account payment
- Payment only still needs UST-1 filed
- Bank information





Electronic Filing Errors

- Call Business Tax: 888-405-4039
 - Snapshot
- Multiple county Vendor's Licenses (VL)
 - Combined
 - VL required for each location
- Electronic filing means UST-1 form must be filled out, spreadsheets are not accepted





Filing Administrator

- Request business access
- Previous filing administrator will need to approve
- Filing administrator letter
 - Company letterhead
 - FEIN/SSN
 - Person name
 - Email/username
 - Brief explanation
 - Owner/officer signature with title listed



Telefile Errors








Telefile Errors

- Telefile Help: 1-800-697-0440
- Use last day of month for date
- If disconnected after filing
 - Confirmation numbers
 - Call back for payment only
- If no access to previous owner's liquor account, Telefile is great option
- Only 1 county



Paper Filing Errors

Paper Errors

- Electronic filing is required
- Fill out county schedule
- Sending check?
 - Add account # and period in memo line
- Submitting electronically? No need for duplicate paper copy
- Do not submit UST-1 forms found online
 - Ohio Department of Taxation will send a form if needed
 - Correct account number
- Paper forms are not in place of errors from other methods
