#### Updates from the State Librarian

- State Librarian Mandy Knapp started on December 31, 2024. Mandy has been meeting with staff in Columbus and Caldwell to get up to speed on plans and initiatives. Many staff from the Ohio Library community attended a Meet and Greet with Mandy on January 16.
- Mandy has launched a Listening Tour to gather feedback on perceptions of the State Library throughout the Ohio library community. There are three phases. The first phase is to meet with staff at all levels at the State Library. The second phase is to meet with representatives from trusted partners and individuals who serve on advisory committees for the State Library. The third phase is to meet with other members of the Ohio library community. The Listening Tour is expected to take the full calendar year to complete.
- State Library budget testimony for the Ohio House Committee on Workforce and Higher Education is schedule to take place on February 11.
- State Library staff in Columbus participated in an in-service day January 27 to prepare for OhioLINK's migration to a new Library Service Platform (LSP). The migration will occur in waves; State Library's wave will be later this year.

# Choose to Read Ohio

- The 2025 <u>Choose to Read Ohio</u> (CTRO) booklist features 20 notable titles for all ages and reading levels, encompassing fiction and nonfiction and a variety of geographic and cultural interests.
- The CTRO Advisory Council creates a <u>readers' toolkit</u> for each CTRO book, featuring author biographies, discussion questions, activities, and resources to engage curiosity and explore themes in depth. Toolkits for all 155 books selected to CTRO since its inception in 2009 are available for free download on the CTRO website. Starting with the 2025 CTRO booklist, toolkits are being published as webpages instead of PDFs for accessibility and findability.
- *The Voice in the Hollow* by Will Hillenbrand has been named the tenth annual <u>Floyd's Pick Book</u> <u>Award</u> winner, awarded by the CTRO Advisory Council in memory of children's literature expert, advocate, and librarian Floyd Dickman.
- The Floyd's Pick Book Award is given annually to a book written by an Ohio author or illustrated by an Ohio illustrator that is representative of high-quality literature created for children. It aims to carry on the legacy of Floyd Dickman's joyful work to support and share children's literature.
- The CTRO Advisory Council has also selected two Floyd's Pick Honor Books for 2025: *My Thoughts Have Wings* by Maggie Smith, illustrated by Leanne Hatch, and *The Yellow Bus* by Loren Long.





• Applications are currently being accepted for the State Library of Ohio's LSTA Summer Library Program (SLP) Grant. The purpose of the SLP grant is to empower libraries to enhance their 2025 summer programs with library-led activities that spark creativity, engage individuals of all ages, and benefit their communities. Libraries may apply for up to \$2,000 in federal LSTA funds to support summer programs for children, teens, and/or adults; a local 25% cash match is required. - The State Library of Ohio's LSTA Celebrating Ohio Book Awards and Authors (COBAA) Grant application window closed on January 12. Applications are currently under review.
  - The COBAA grant program invites Ohio libraries to apply for up to \$2000 in grant funds to support collection development and collection-related program initiatives for their communities. The initiative supports the purchase of books by Ohio authors as well as books recognized by Ohio-based book award programs.
- The application period for Cycle 2 of the State Library of Ohio's LSTA Open Grant initiative closed on December 31. State Library staff will review applications and recommend not more than six projects for funding.
  - LSTA Open Grant projects will begin on March 1, 2025, and be completed by August 31, 2025.

## **Meeting Rooms**

In January, 407 hours of meetings were held in our 7 meeting spaces by groups including the Ohio Department of Development, Ohio Department of Education and Workforce, Ohio Department of Health, Ohio Department of Job and Family Services, and many others.

## Ohio Digital Library

- In the month of January, ODL patrons checked out **957,633** items.
  - The most popular non-magazine title in January was *Onyx Storm* by Rebecca Yaros—the third book in her popular fantasy romance series. The most popular magazine title was *The New Yorker*.
- In mid-March 2020, ODL enabled the opportunity for Ohioans to take advantage of the Overdrive Instant Digital Card. A user can sign up with their phone number and gain quick access to e-content via ODL. Users that sign up via the Instant Digital Card will be directed to their local library to fill out a physical library card. In January 2025, 5,521 registrations took place.

#### **Ohio Memory**

- <u>Ohio Memory</u> is the collaborative statewide digital library program of the Ohio History Connection and the State Library of Ohio. On this free <u>website</u>, you can explore digital content from over 390 cultural heritage institutions representing all 88 of Ohio's counties covering a wide range of topics from prehistory to present day.

#### Ohio Ready to Read

- Ohio Ready to Read (ORTR) provides library-oriented resources on the <u>science of reading</u>, including webinar recordings, articles, and other tools. This resource collection is part of ORTR's <u>Kindergarten</u> <u>Readiness and Student Learning</u> guide for Ohio public libraries.
- <u>Early Literacy 101</u> is a free, full-day (6 contact hour) hands-on workshop to help library staff build a firm foundation in early literacy. Participants learn how brain development impacts how young children learn; discover effective, research-based early literacy resources and activities; and explore how storytime supports early literacy. <u>Learn more about the workshop</u>. 2025 workshop dates will be announced in coming months. - Penelope Shumaker gave a presentation to the State Library Board on January 16, sharing information on the Ohio Digital Network, DPLA, and the State Library of Ohio's ongoing commitment to digital heritage and digital preservation.
- Penelope Shumaker led the 2025 Library Juice Academy cohort kick-off on January 8, providing guidance and instruction for what the cohort should expect to encounter as they complete the coursework necessary to obtain their desired certification.
- In support of ILEAD Ohio, Erin Kelsey (along with other State Library and OhioNet staff members) facilitated two "Team Lab" sessions, where interested parties could learn more about the ILEAD Ohio program, as well as make connections toward assembling a team in order to apply.



#### Services for the Blind and Print Disabled

- Library services for the blind and print disabled in the United States are delivered through a network
  of libraries and agencies coordinated by the <u>Library of Congress National Library Service for the Blind
  and Print Disabled (NLS)</u>. In partnership with the Ohio Library for the Blind and Print Disabled (OLBPD)
  at the Cleveland Public Library, the State Library of Ohio serves as the machine lending agency for the
  state providing playback equipment to eligible blind, visually impaired, and print disabled residents.

## Summer Food Service Program/SUN Meals

- Many libraries in Ohio and around the USA participate in the **Summer Food Service Program (SFSP)**, **now branded as SUN Meals**. This USDA-funded program provides free meals and snacks to children ages 0-18 in communities with high levels of need. Besides the obvious benefits of addressing hunger and supporting vulnerable youth, SUN Meals participation benefits libraries through:
  - Access to new user groups, especially underserved and marginalized populations
  - Increased visibility of the library as a community asset
  - Opportunities for new partnerships
  - Positioning of the library as an important stakeholder in community well-being and positive child outcomes
  - Support for summer library programming through increased attendance
- If you are already a SUN Meals / SFSP site or have been in the past, work with your current/previous sponsor to prepare for summer 2025.
- If you want to become a SUN Meals site, the Collaborative Summer Library Program offers a thorough, clear how-to guide: <u>Libraries and Summer Food</u> provides a step-by-step for libraries interested in becoming SUN Meals sites, or otherwise getting involved in addressing child food insecurity during the summer.
