

# Ohio Computerized Criminal History (CCH)

- CCH is a comprehensive database of arrests made by Ohio law enforcement agencies for felonies, reportable misdemeanors, and other specified offenses, along with the dispositions of those arrests.
- The Criminal History Database is fingerprint based
- All information depicted on a CCH Rapsheet is supported by either ten-print fingerprint submissions received from Law Enforcement agencies or disposition data received from the courts.

# Background Check Processing Time

- 80.44% of incoming background checks do not require manual review and are completed the same day
- 84.61% of the total number of background checks requiring manual review are completed within 14 days
  - 42.84% are completed in under 7 days
  - 41.77% are completed between 7-14 days
  - This information was obtained from statistical data provided on July 28, 2025


