Re: Notice of Mass Layoff Under the WARN Act

To Whom It May Concern:

On behalf of American Signature, Inc. (a.k.a. Value City Furniture) (the "Company"), this letter is to notify you of an upcoming "mass layoff" within the meaning of the Worker Adjustment and Retraining Notification Act of 1988 (the "WARN Act"), in accordance with the WARN Act and the Ohio Worker Adjustment and Retraining Notification Act, Ohio Revised Code § 4413.31 (the "Ohio Mini-WARN Act").

The mass layoff will occur at the Company's facility located at 4300 East Fifth Avenue, Columbus, Ohio 43219 (the "Facility"), due to significant decline in sales, resulting liquidity challenges, and the Company's anticipated Chapter 11 bankruptcy filing. To mitigate or avoid the layoff, the Company took cost-reduction steps and explored financing options to stabilize the business, but these efforts were ultimately insufficient to avoid the layoff.

In this mass layoff, the Company expects that it will lay off 326 employees. Of this number, approximately 256 employees are residents of Ohio. The remaining employees reside in other



states. Information regarding the job titles of the positions to be affected and the number of affected employees in each job classification, is outlined in <u>Exhibit A</u> attached hereto.

Each of the affected employees will receive the 60 days' notice required under the WARN Act and the Ohio Mini-WARN Act. The mass layoff will take place, and thus the employment terminations will take effect, on January 20, 2026 or within the 14-day period beginning on that date, although it is expected that certain affected employees will remain employed for a limited time after this window to assist with administrative and business tasks related to the mass layoff. Other than these certain employees, the entire Facility is being closed. The Company expects this layoff to be permanent. Employees are not represented by a union and there are no bumping rights.

As indicated on the Copy of the Employee WARN Notice attached hereto as Exhibit B, affected employees have been advised that information regarding any dislocated worker assistance programs is available through the Ohio Dislocated Workers Services of the Ohio Department of Jobs and Family Services; that they may apply for Unemployment Benefits after their last day of employment by applying online at: https://jfs.ohio.gov/job-services-and-unemployment or over the phone by calling (877) 644-6562, and that the call center hours are Monday through Friday 8 a.m. to 5 p.m; and that they may also access Job Services online at the link above or visit one of the OhioMeansJobs local agencies for additional resources: https://jfs.ohio.gov/about/local-agencies-directory/local-agencies-directory.
