To whom it may concern:

Please be advised that, on May 31, 2026, Taikisha USA, Inc. will permanently close its Columbus, Ohio facility located at 1939 Refugee Road, Columbus, Ohio 43207. Separation of the affected employees is expected to be permanent, and the expected date of the first separation is anticipated to be on May 31, 2026.

Attached is a list of the job titles for the positions affected, the number of affected employees in each job classification, and the anticipated schedule for their separations. No employees will have bumping rights, which means that those employees will not be able to displace more junior employees out of their job positions as a result of this closure.
