**Re: New Horizons Baking Company, LLC  
Closure of Facility at 1015 New York Avenue, Toledo, Ohio 43611**

This letter serves as formal notice that New Horizons Baking Company, LLC's ("NHBCo") plant located at 1015 New York Avenue, Toledo, Ohio 43611 (the "Plant") will close on or after Tuesday, March 17, 2026. Employee separations via permanent layoff as a result of this closure are expected to begin on or after March 17, 2026.

The decision to close the Plant was based on NHBCo's goal to support long-term business efficiency, consolidate locations, and encourage strategic growth. Limitations in the infrastructure within the Plant prevent it from supporting these legitimate business goals.

The employee separations via permanent layoff will impact a total of 68 employees (the "Impacted Employees"), and includes those with the following job titles:



Employees in the listed positions are represented by the United Steel, Paper and Forestry, Rubber, Manufacturing, Energy, Allied-Industrial and Service Workers International Union, AFL-CIO-CLC, Local 1-377 (the “Union”). Both the Union and the Impacted Employees have received notice of the closure and impending permanent layoff through written notice as required by both the Federal and Ohio Workers Adjustment and Notification Act

Inasmuch as the Plant is closing in its entirety the unionized Impacted Employees do not have bumping rights.
