**Re: NOTICE OF LAYOFFS BY FIRST FINANCIAL BANCORP PURSUANT TO
20 C.F.R. § 639.7(e)**

Dear Breeyn Tarr,

Please be advised that, on or around March 19, 2026, First Financial Bancorp ("Company") will begin permanently laying off a number of its employees at its Seville Operations Center located at 4940 Enterprise Pkwy, Seville, OH 44273. The separations of the affected employees are expected to occur in waves, starting on the dates included below. Consistent with these plans, the last day of employment at the Company for the affected employees is anticipated to be one of the following dates or within 14 days thereafter:

- March 19, 2026
- April 17, 2026
- May 18, 2026
- June 17, 2026
- September 15, 2026

A list of the affected job titles and number of employees per classification is attached as **Exhibit A**. First Financial Bancorp mitigated the impact of these layoffs by offering employees the opportunity to be considered for roles with Company. In addition, Company provides severance pay, a COBRA premium subsidy, payment of accrued but unused paid time off, career transition services and unemployment benefit information to eligible employees who will exit as a result of the acquisition. The affected employees are not represented by any union. All layoffs will be permanent, and no bumping rights exist. A copy of the notice provided to affected employees is attached as **Exhibit B**.


