*Re: Updated Notice of Layoffs of OhioHealth Associates Previously Communicated on
November 3, 2022*

Dear Rapid Response Unit, Mayor Ginther, the Franklin County Board of Commissioners and
Dublin City Council:

On November 3, 2022, OhioHealth Corporation ("OhioHealth") provided you with written notice
of a layoff impacting OhioHealth associates. (See Attached November 3 Letter). Although
OhioHealth remains of the position that the Worker Adjustment and Retraining Notification
("WARN") Act likely does not apply to this layoff, OhioHealth is providing you this updated

notice because it inadvertently missed one employee from its November 3, 2022 correspondence. This is **not** notice of a new layoff – this is the same layoff announced internally by OhioHealth in July 2022 and the subject of OhioHealth’s November 3, 2022 notice correspondence.

The below reflects the individuals previously disclosed plus the one individual who was inadvertently missed.

- OhioHealth will be laying off approximately 315 associates.
- Approximately 287 of these associates work remotely at their own residences. These 287 associates who work from home are assumed to be assigned to the OhioHealth Blom Administrative Campus, located at 3430 OhioHealth Parkway, Columbus, OH 43202, for purposes of this notice.
- All 315 associates are being permanently laid off.
- Attached is an updated list of the job positions and number of individuals who will be affected by the layoff that denotes the one individual inadvertently left off.

Like OhioHealth’s November 3, 2022 notice, this updated notice is not intended, and should not be construed, as an admission that this notice is required under the WARN Act or to any particular associate. All rights and defenses pursuant to the WARN Act and other laws are specifically reserved.

Re: Notice of Layoffs of OhioHealth Associates

Dear Rapid Response Unit, Mayor Ginther, the Franklin County Board of Commissioners and Dublin City Council:

In July 2022, OhioHealth Corporation ("OhioHealth") internally announced that it would be eliminating certain jobs in its Information Technology Department beginning in January 2023. The purpose of this correspondence is to notify you that consistent with the previously announced reduction in force, OhioHealth will be laying off approximately 314 associates. Approximately 286 of these associates work remotely at their own residences. The site of employment and address of the approximately 286 associates is their home address, meaning there is no Worker Adjustment and Retraining Notification ("WARN") Act notification obligations.

Even though no notice is required, OhioHealth is providing this notice out of an abundance of caution and consistent with the WARN Act's encouragement to provide notice in ambiguous

situations. Specifically, determining the site of employment for remote workers may be ambiguous under current law. Assuming, without admitting, that the site of employment for these remote workers is a location other than their personal residences, OhioHealth is laying off associates as follows:

1. 286 associates who work from home but for purposes of this notice are assumed to be assigned to the OhioHealth Blom Administrative Campus, located at 3430 OhioHealth Parkway, Columbus, OH 43202.
2. Two associates who work on-site at the Blom Administrative Campus, located at 3430 OhioHealth Parkway, Columbus, OH 43202.
3. 17 associates who work at OhioHealth's Perimeter Drive location, located at 6805 Perimeter Drive, Dublin, OH 43016.
4. Two associates who work at the OhioHealth Data Center, located at 755 Thomas Lane Columbus, OH 43214.
5. One associate who works at OhioHealth's Mansfield Hospital, located at 335 Glessner Avenue, Mansfield, OH 44903.
6. Three associates who work at OhioHealth's IS Security/IT Integration location, located at 3650 Olentangy River Road, Columbus, OH 43214.
7. One associate who works at OhioHealth's Berger Hospital, located at 600 N. Pickaway Street, Circleville, Ohio 43113.
8. One associate who works at the OhioHealth's Barks Road Office, located at 278 Barks Road W., Marion, OH 43302.
9. One associate who works at OPG Gynecology, located at 3600 Olentangy River Road, Suite A, Columbus, OH 43214.

All 314 associates are being permanently laid off. All OhioHealth locations listed above will remain open. 309 associates are expected to be separated on January 3, 2023, while two associates have been given the option of staying with OhioHealth up to and through February 20, 2023 before being separated, and three associates have been given the option of staying with OhioHealth up to and through February 28, 2023 before being separated.

All affected associates are being or have been notified of their respective layoff dates of January 3, February 20, or February 28, 2023. Attached is a list of the job positions and number of individuals who will be affected by the layoff. There are no bumping rights associated with this layoff and none of the associates are represented by a union.

This notice is not intended, and should not be construed, as an admission that this notice is required under the WARN Act or to any particular associate. All rights and defenses pursuant to the WARN Act and other laws are specifically reserved.
