To Whom it May Concern:

As you are aware, First Brands Group, LLC (the “Company”) previously notified you on February 27, 2026 that it expects to commence the permanent closure of the entirety of the Cleveland Corporate Office facility located at 127 Public Square Suite 5300, Cleveland, OH 44114 (the “Facility”) on April 30, 2026.

We are writing to update you that the Company now expects that 105 employees will be terminated effective on April 30, 2026, and 5 will be terminated on June 30, 2026. This letter constitutes notice to you, pursuant to the Worker Adjustment and Retraining Notification Act of 1988 and Ohio Revised Code § 4113.31.

The Company expects the closing of the Facility to be permanent. Because this is a complete closure of the Facility, bumping rights are not applicable.

As stated in the Company’s prior correspondence, the Company is currently experiencing a period of financial distress and is in a chapter 11 bankruptcy process. Nevertheless, the Company has gone to great lengths to maintain its operations. This has included pursuing a sale process as well as attempting to seek additional funding from numerous outside parties. However, under all of these circumstances, the Company has now made the difficult decision to close this Facility.

As in the Company’s prior correspondence to affected employees, employees have been encouraged to contact the Ohio Department of Job & Family Services at 30 E Broad St, Columbus, OH 43215, (614) 466-6282 to learn about available services, such as unemployment compensation information, job matching, funding for training, resume writing, interview preparation, and hiring events. First Brands Group, LLC (the “Company”) regrets to inform you that it will be closing the entirety of the Cleveland Corporate Office facility located at 127 Public Square Suite 5300, Cleveland, OH 44114 (the “Facility”). This letter constitutes notice to you, pursuant to the Worker Adjustment and Retraining Notification Act of 1988 and Ohio Revised Code § 4113.31.

As you may be aware, the Company is currently experiencing a period of financial distress and is in a chapter 11 bankruptcy process. Nevertheless, the Company has gone to great lengths to maintain its operations. This has included pursuing a sale process as well as attempting to seek additional funding from numerous outside parties. However, under all of these circumstances, the Company has now made the difficult decision to close this Facility.

The Company expects that 110 total employees will be affected by this closure. The Company expects that the closure will commence on April 30, 2026 and that all 110 employees will be terminated effective on that date. At this time, the Company expects the closure to be permanent. Bumping rights are not applicable.
