RE: Notice of Facility Closing under the Worker Adjustment and Retraining Notification Act

Dear Ohio Department of Job & Family Services:

The CommuniCare Family of Companies dba Advanced Specialty Hospitals of Toledo (the "Company") is writing to inform you that as part of a recent transaction, the decision has been made to close the LTACH facility (the "Facility"), effective on May 1, 2026. As a result of this decision, the Company must lay off all Company employees at the Facility, effective on June 8, 2026. The address is: 1015 Garden Lake Parkway, Toledo, Ohio 43614.

Accordingly, this letter is to notify you that 116 employees at the Facility will be affected. The group includes only non-union employees, and the Company will terminate all employees at the Facility on June 8, 2026. The positions that will be affected, together with the number of employees in each position, are set forth on the attached list. Bumping rights are not applicable to this layoff. Additionally, employees will continue to receive wages through June 8, 2026.

Employees received information on how to access unemployment insurance benefits and other assistance programs, such as job placement assistance, retraining programs, and counseling services.
