

Library consultants **Katy Hite** and **Janet Ingraham Dwyer** are facilitating a tri-state cohort of Building Community-Based Summers, a three-month professional development opportunity that empowers library staff to develop summer services with community at the center.

Participating public library staff members work with Katy and Janet and each other to consider summer programs through a community-focused lens. The cohort includes teams from Ashland Public Library, Chillicothe & Ross County Public Library, and Dayton Metro Library,

along with teams from two Indiana libraries and five Michigan libraries. The libraries were selected through a competitive application process. Cohort meetings began with an orientation in late-September, and is followed by weekly learning sessions through mid-December on "The Whys of Summer," "Letting Go of Traditions," "Connecting with Community, "Summer Services Impact," and other related topics.



LPD Staff Spotlights

The State Library of Ohio hosted a virtual Reimagining School Readiness Workshop on October 14 with 19 library staff members in attendance. Led by Library Consultant **Penelope Shumaker** and Pam Brockway (Public Library of Youngstown and Mahoning County), participants received materials in advance of the workshop that equipped them to engage in hands-on activities and discussions.

Associate State Librarian **Evan T. Struble** led the Ohio Public Library Information Network (OPLIN) Board of Trustees through a visioning exercise. Through group facilitation skills and strategic planning discussion prompts, the OPLIN Board was challenged to consider how the organization might grow and change in the coming years, while still providing the excellent services for which it's currently known.

The annual ODNFest event was held at the State Library of Ohio with more than 30 library professionals from across Ohio in attendance.




